NOTICE OF VIOLATION

Nulife Glass NY, Inc. Dunkirk Facility, #07Z04 Part 360 Permit #9-0664-00035/02001 Financial Assurance

This letter serves to provide you with a Notice of Violation ("NOV") setting forth the specific actions that constitute violations involving Article 27, Title 7, of the New York State Environmental Conservation Law ("ECL") and Permit #9-0664-00035/02001, in connection with your operations conducted at 3213 Middle Road, Dunkirk, Chautauqua County, New York (the "facility"). This NOV is issued because NuLife Glass NY failed to submit a surety instrument to the Department for closure costs associated with the facility by March 11, 2014.

In response to NuLife's request to reduce the amount of the surety required by the subject Permit, the Department has reviewed numerous revised closure cost estimates provided by NuLife. To date, an acceptable revised closure cost estimate has not been provided and the required surety has not been supplied by Nulife Glass.

PLEASE TAKE NOTICE THAT YOU ARE IN VIOLATION OF:

- 6 NYCRR Part 360 Permit #9-0664-00035/02001, Special Condition 8 failure to submit a surety instrument in an amount sufficient to cover one-half of the anticipated cost of closure of the facility; and
- 6 NYCRR Part 360 Permit # 9-0664-00035/02001, Special Condition 30 failure to maintain a surety instrument, acceptable to the Regional Materials Management Engineer (RMME), to assure the proper closure of the facility.

PLEASE TAKE NOTICE THAT:

 The Department is reviewing its options regarding the appropriate enforcement actions, including assessment of penalties, fines and injunctive relief for the violations which



have already occurred. You should take immediate actions (see attached compliance schedule) to ensure that all on-going violations cease. Compliance with this **NOTICE** by immediately correcting the violations shall not relieve you of any liability for penalties or appropriate sanctions for the above-referenced violations. However, failure to comply with this **NOTICE** by correcting the violations in accordance with the attached schedule could result in a larger penalty than would otherwise be assessed, should you be adjudged to be in violation of the law.

ECL 71-2703 provides that any person who violates any of the provisions of, or who fails
to perform any duty imposed by ECL Article 27 or any rule, regulation, determination or
order of the department made pursuant to this title, or any permit condition shall be liable
for a civil penalty not to exceed \$7,500 (Seven Thousand Five Hundred Dollars) per day
for each violation and an additional penalty of \$1,500 (One Thousand Five Hundred
Dollars) for each day during which such violation continues.

PLEASE TAKE FURTHER NOTICE THAT:

 You may submit information or evidence to the Department relevant to your compliance record, the nature of the violations, or any mitigating circumstances. Any such information or evidence may be used in a civil enforcement proceeding or criminal action. In the event that formal enforcement proceedings are initiated or criminal charges filed against you, you will have the right to a hearing.

NuLife Glass Notice of Violation

Compliance Schedule

Respondent shall, on or before the dates indicated:

ITEM

- Submit an Updated Closure Cost Estimate, based on the maximum amount of material expected to be stored at the Dunkirk facility six months into the future. The estimate must include cost for off-site disposal of the following:
 - Whole CRTs
 - Unprocessed Leaded Glass
 - Panel Glass
 - Processed Leaded Glass (feed stock for furnace)
 - De-Leaded Glass (from furnace)
- 2. Submit a surety instrument, acceptable to the Department, for proper closure of the Dunkirk facility.

COMPLETION DATE

January 1, 2016

Within 30 days of Department approval of an updated Closure Cost Estimate
